#### CPCS CHANGES VENDOR INVOICE DEADLINES



As many clients are aware, Case In Point has been taking publicly funded cases throughout New Hampshire, Connecticut, Rhode Island, Massachusetts, and Florida for more

than 11 years. Even though rates are capped by state law, CIP is proud to apply the same intense work ethic as in privately funded matters.

In this vein, CIP wants to take care to notify clientele that the Committee for Public Counsel Services in Massachusetts is cracking down on the time limit for vendors to submit invoices. Beginning this past summer, from the day any work is conducted, CIP has 30 days to enter it into the V-Bill site.

Case In Point has always taken care to enter invoices into the system within days. Thus, CIP will continue to appreciate the diligence of attorney clients in submitting required information as soon as possible. The documents necessary are a signed and dated order for funds and the NAC number.

Office Manager Michelle Carpentier states, "The earlier it's provided, the

smoother the process becomes for everyone."

In addition to providing the billing requirements at the onset, Ms. Carpentier reminds that police reports, complaints, court transcripts, and instructions or theories from counsel help the assigned investigators as well.




